The Netherlands Antilles ceased to exist on 10 October 2010. As from that date, the PCT continues to apply to Curaçao and Sint Maarten. The PCT also continues to apply to the islands of Bonaire, Sint Eustatius and Saba which, with effect from 10 October 2010, have become part of the territory of the Kingdom of the Netherlands in Europe.<sup>6</sup> Extends to the Isle of Man.<sup>7</sup> With the declarations provided for in PCT Articles 64(3)(a) and 64(4)(a).<sup>8</sup> Extends to all areas for which the United States of America has international responsibility.
